Have you been sexually assaulted, abused, or harassed?

Sexual violence can occur in different ways, but know that it's **never your fault**.

Sexual contact or behavior that happens without your consent and qualifies as sexual violence can include:

- ***Unwanted touching or fondling***
- ***Forced sexual acts***
- ***Rape or penetration of any kind***
- ***Attempted acts, even if the attempt is prevented or stopped***
- ***Jokes or lewd behavior at work or school***

Intimidation, manipulation, and humiliation are all non-physical forms of abuse that offenders use to pressure sexual acts.

How Legal Aid Chicago can help you!

Legal Aid Chicago offers **free** comprehensive civil (non-criminal) legal services to individuals who are survivors of sexual violence.

PERSONAL SAFETY

You may be eligible for a protective order that keeps you and your household members safe.

IMMIGRATION

You may be eligible for a U-visa or other immigration relief as a crime victim that gives you permission to live and work in the U.S.

HOUSING

You may have the right to break your lease or change the locks if you feel unsafe in your apartment. Your landlord cannot evict you for calling the police or for getting an order of protection.

Sexual abuse by a landlord is illegal.

EMPLOYMENT

If you experience sexual abuse at work, or are fired or mistreated because you are a victim of sexual violence, you may be able to sue your employer. You may also be eligible for unemployment benefits.

You may be eligible for unpaid time off work for matters such as medical and legal appointments related to sexual violence.

PUBLIC BENEFITS

You may be eligible for TANF Crisis Assistance, expedited SNAP (food stamps), crime victim compensation, and/or disability benefits.

FINANCIAL

You may dispute medical debts that stem from the sexual violence. We may be able to assist with identity theft, especially in cases of human trafficking.

EDUCATION

You may have the right to extra supports in school to help you feel safe, including time with a school social worker, changes to your or the perpetrator's schedule, or a transfer to another school.
